UEM Sunrise Reports Financial Results for Six Months Ended 30 June 2015

UEM Sunrise Berhad ("UEM Sunrise" or the "Company") recently announced its financial results for the sixth months ended 30 June 2015; whereby total revenue stood at RM789.8 million as compared to RM849.2 million recorded in the corresponding period of 2014. Although the total revenue achieved saw a decrease of 7% as compared to 2014, profit after tax and non-controlling interest ("PATANCI") increased by 1% to RM137 million as compared to RM136 million recorded in the same period last year.

Property development activities contributed almost 91% of the total revenue for the current period. The three major revenue contributors were Teega in Puteri Harbour, Nusajaya; Quintet in Vancouver, Canada and Arcoris Mont'Kiara, Kuala Lumpur in line with higher construction progress recorded for the projects.

Total property development sales for the period improved to RM600.4 million from RM438.9 million achieved in 2014 driven mainly by international sales from the Aurora Melbourne Central project in Melbourne, Australia which contributed sales of RM267.3 million for the current period. Locally, Residensi22 Mont'Kiara has also achieved overwhelming response recording over 90% sales to date. Unrecognised revenue as at 30 June 2015 stood at RM3.8 billion as compared to RM3.0 billion recorded in 2014.

HSBC Forum – RMB and China's Global Future

HSBC Malaysia hosted the "RMB and China's Global Future" forum recently, bringing together a group of renowned experts to discuss topics relevant to Malaysian businesses - Malaysia China trade and the prospect of using Renminbi (RMB) in cross border trade.
